

- Replace all roadside systems for the Open Roll Tolling (ORT) zones on the Downtown Expressway and Powhite Parkway and provide related system maintenance services
- Improve performance, reliability, scalability & security of the systems at the ORT zones
- Procure a solution that is based on an existing production system with little to no customization
- Be cost effective
- Compressed implementation time frame

Procurement Objectives



- Establish agreement with the Proposer whose proposal is the most advantageous to the RMTA
 - ✓ Qualified firm with ORT solution currently in revenue service and providing system maintenance
- Use functional level specifications to permit Proposers flexibility in design and development of the System
- System shall utilize proven and reliable technology capable of meeting service level agreements (SLAs)
